# WRIGHTSTOWN COMMUNITY SCHOOL DISTRICT ANNUAL MEETING September 28, 2022

Board President Nicole Gerend called the meeting to order at 6:01 p.m. The meeting opened with the Pledge of Allegiance.

#### **Election of Annual Meeting Chairman:**

Nicole Gerend was appointed as chairman of the meeting.

#### **Budget Presentation and Financial Highlights:**

Dan Storch reviewed the 2022-23 budget, presenting an overview for the upcoming school year, reviewed historical budget information and comparative data.

Questions raised by Angela Hansen-Winker related to the tax levy, budget, and mill rate were answered.

## **District Highlights:**

Carla Buboltz and the administration team reviewed district highlights.

#### **Consider Motions:**

Nelson made a motion to raise the Board of Education salaries 4.7%. President-from \$2,403 to \$2,514 and Other Officers/Directors-from \$2,198 to \$2,301. Seconded by Mihalski. Motion approved.

Van Vreede made a motion to approve a resolution authorizing the Board of Education to sell personal property no longer needed by the district. Seconded by Cunningham. Motion approved.

Van Vreede made a motion to approve a resolution authorizing the Board of Education to establish future annual meeting dates. Seconded by Boland. Motion approved.

Gerend made a motion to adopt a 2022-23 school tax levy of \$3,966,321.00 General Fund and the Debt Service Fund \$4,635,000.00; and the Community Service Fund at \$200,000.00 for a total district tax levy of \$8,801,321.00. Seconded by Cunningham. Motion carried.
